Sir,

In Producing here with one arrested accd. Person namely Paresh Kuiry (34) S/O Saktipada Kuiry of Vill. Dibiritikar, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 01 plastic bag containing 37 (Thirty Seven) bottles of RAMBO (Country spirit) each bottle 600 ml. from his possession. I do hereby lodged this written complain to the effect that on-09/07/2017 at 1915 hrs. I received telephonic source information that one person selling (Country spirit) at Dibiritikar Village. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with SI T. K. Dawn C/12 Gostha Bihari Mahato C/765 Lalman Marmu C/1492 Dilip Ch. Garain vide C.C No. 2139/ 17 Dtd- 09/07/17 left for Dibiritikar village to work out the information. We reached at Dibiritikar Village at about 20:15 Hours and held raid in the house of Paresh Kuiry (34) S/O Saktipada Kuiry of Vill. Dibiritikar, P.S. Jhalda, Dist. Purulia and found that the accused person selling RAMBO in his grocery Shop. Accordingly I seized the 01(One) plastic bag containing 37 (Thirty Seven) bottles of RAMBO (Country spirit) each bottle 600 ml. under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses.

Accordingly I arrested accd. Paresh Kuiry (34) S/O Saktipada Kuiry of Vill. Dibiritikar, P.S. Jhalda, Dist. Purulia having maintained all formalities after issuing arrest memo. On integration he confessed that he selling the said RAMBO (Country spirit) to the villagers in lieu of money. On demand he could not produce any valid documents/license in favour of selling the same. So he committed offence punishable U/S - 46(A)(c) of B.E. Act. 1909.

On return to P.S. along with accd. person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Paresh Kuiry (34) S/O Saktipada Kuiry of Vill. Dibiritikar, P.S. Jhalda, Dist. Purulia under proper section of law.
