In producing besewith the arrested accused personn namely (1) Kartick Kanda (30) s/o Notal Kanda of Builda Giatri Mandir Ward no-3, (2) Godma Kaji (36)\$70 Farad Kaji of Kantadi, (3) Hijay Mandal(43) S/O Lt. Namda Mandal of Builda Chatanipara Ward no-5, (4) Jayanta Sen (20) S/O Aditya Sen of Builda Anandabazar (5) Dayal Chandra (34) S/O Buildya Nath Chandra of Builda Dome Para (6) Ananda Kr. Yadab (25) S/O Shyamoundar Yadab of Builda Chank Bazar (3) Jeet Chandra (28) S/O Durgadas Chandra of Jhalda Ward no-9,(8) Sk Irlan (34) S/O Sk Manir of Parano Jhalda. (9) Sk Minac(38) S/O Sk Khalil of Kantadih (10) Sunil Kanda (80) S/O Sasabha Kanda of Jhalda Dome para, all of P.S. Builda Dist-Purulia (11) Kanad Mahata (38) S/O Manindra Nath Mahata of Vill-Nalkupi, (12) Fuchu Kumar (25) S/O Hem Kumar of Madkuma (13) Senapati Gorait (58) S/O Learu Kumar of Madkuma all of P.S. Kotshila Dist-Purulia before yon, along with seized articles like board money amounting to RS-80755/- (Eighty thousand Seven Hundred fifty five Rupees only) and 113 nos of playing cards, etc. as per seizure list.

1 beg to report that on 11/07/17 at 17:45 hrs, received a credible secret information that ove gambling with hope amount was going on at New Friends Union Club, Chewk Buzar under Budda PS. The matter was charies vide Budda PS G.D.E No. 424 Dtd. - 11/07/17 accordingly as: ger order of DC Builds P.S.I.S.I.Sahadeb Jana along with (1) ASI Pankaj Kumar Gupta(2) ASI Moras Panda,(3) C/1147 Bappaditya Nandi, (4) C/1492 Dilip Gorain, (5) JC/559 Amiya 5. M. Patraztin JC/001 Bikram Kalindi vide C/C No. 148 (7):17 in vehicle No. WB-56D 9060 to. 2015), out the information. At about 18:15 hrs. We reached near New Eriends Union Club and very slowly and cautiously approached towards the door of the club, where the gambling was o portedly going on, we over heard the talking of persons present there and within a few moment. it is as clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my avere are staffs to exist on the place and within a moment the place was cordoned by Police party. We disclosed our identity and requested them to search said party accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we will oil their identity and the persons disclosed their name and address as rested above. It was fewed that a bage amount of currency note of different denomination were kept on gaming board (White Firstic Sheet placed on the floor) and playing eard were also found. On demand the persons clearly confessed that all of them were doing gambling with playing eards in exchange of each for wrongful loss to one and wrongful gain to another with full knowledge. We searched for the public witnesses but none was available. At about 18:25 hrs. we searched their persons and found wave personal belonging, eash and Ontaments etc. All articles were seized under proper seizure his as personal property from 18:35 hrs. to 18:45 hrs. duly signed by our staff and supplying copy. to them. After that in presence of persons noted above, the board money of Rs 807550; (Eights) th yound Seven Hundred fifty five Rupees only) with different demonitution, 113 mm of Playing cards and thus White Plastic Sheet were seized for the gaming board in between H645 hrs. to 19-25 hrs. Under proper science list which is duly signed by the accused also.

As such for committing offence ponishable u/s- 3 & 4 of W.B.G.& P.C. Act all the above used 13 (Thirteent persons were assested, issuing arrest messo and Inspection messo between 19.25 hrs. to 19.45 hrs.

I nom the statement of accused persons it was clear that the garning was going on under guidance and full of knowledge of the Secretary of said New Friends Union Club, of Jhalda Chowk Bazar, P.S.-Bolda, Dist. - Purulin.

Therefore I gray before you that one specific case may kindly be start under proper section of law against the above noted accused persons along with the Secretary of New Friends Union 1 Inh, Builda Chouk Bazar ,P.S.-Builda, Dist.-Purulia and arrange its investigation.
