Sir.

In producing herewith one accused person namely Dilip Karmali (19) S/o-Biswanath Karmali of Vill-Goria, PS-Jhalda, Dist-Purulia along with 03 (Three) seized Motorcycles as per seizure list. I ASI Pankaj Gupta of Jhalda PS lodged a complaint against the above noted accused person to the effect that on 23.07.17 at 14:15 Hrs. received a credible source information from my reliable source that one Dilip Karmali (19) S/o-Biswanath Karmali of Vill-Goria, PS-Jhalda, Dist-Purulia and others unknown engaged in the business of stolen Motorcycles at present accumulated some stolen motorcycles in an under construction house (Indira Abas) just beside his house at village Goria, PS-Jhalda, Dist-Purulia. This information communicated to I/C Jhalda PS and noted in G.D vide GDE No-890 Dtd-23.07.17. As per direction of I/C Jhalda PS, I ASI Pankaj Kr. Gupta along with officer ASI Sourav Kanti Das and ASI Manas Kr. Panda and force namely 1) Constable-380, Ajoy Krishna Roy 2) Constable-1147, Bappadittya Nandi 3)' Constable-1166, Nabin Majhi left PS at 14:25 Hrs. to work out the source information vide Jhalda PS GDE No-891 and C.C No-2223/17 Dtd-23.07.17. We reached at the spot with my source at about 15:15 Hrs. and keeping our vehicle in a safe distance, we held raid at about 15:20 Hrs. in an under construction(Indira Abas) house just beside the house of accused Dilip Karmali. During raid, the accused Dilip Karmali and others 3/4 persons tried to flee away seeing the police party but due to hot chase, the accd Dilip karmali caught red handed and the others 3/2 managed to fled away. On searching we found 03 (Three) Motorcycles in the under construction house(Indira Abas) just beside the house of accd. Dilip karmali and asked him to produce the relevant documents in respect of following Motorcycles but he failed to produce any valid documents in respect of the following Motorcycles and during interrogation he clearly confessed that he along with 1. Parikshit Karmali (22) S/o-Biswanath Karmali of Goria, PS-Jhalda, Dist-Purulia 2. Bikash Karmali @ Sahil S/o-Santosh Karmali of Goria, PS-Jhalda, Dist-Purulia, A/P-Kedla, No-15 Colliery, PS-Mandu, Dist-Ramgarh (Jharkhand) and others unknown (whose name are unknown to him) of Jharkhand state habitually deal with the business of stolen motorcycles in a clandestine manner since last few years. I seized the following Motorcycles after preparing proper seizure list duly signed by accused person, as well as family member and accompanied Police persons because the local people refused to sign in seizure list.

- 1) One Hero Passion Pro Motor Cycle (Black Colour) having Registration No-WB-56F/2361, Engine No-HA10ENCGE48145, Chassis No-MBLHA10AWCGF16586.
- 2) One Pulsar-150 Motor Cycle (Black Colour) having Registration No-JH-01BJ/9138, Engine No- DHZCEH39834, Chassis No-MD2A11CZ5ECH60218.
- 3) One Honda CBR Motor Cycle (White &Black Colour) having Registration No-JH-03M/4003, Engine No-AC17E8008843, Chassis No-ME4KC181JC8003265.

I arrested accused Dilip Karmali (19) S/o-Biswanath Karmali of Vill-Goria, PS-Jhalda, Dist-Purulia after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with all 03 (Three) seized motorcycles.

Therefore I pray that a specific case may kindly be registered against the above noted accused person under proper section of law.
