In producing here with one arrested accused person namely (i) Sk. Abdul (22 Yrs.) S/O Sk. Asrab of Vill- Hossendih, P.S- Jhalda, Dist.- Purulia and brought under seizure the following articles (i) Total 45 (Forty five) bottles of COSCODIN-T cough syrup(Codeine Phosphate & Triprolidine Hydrochloride Syrup) contain 100 ml in each bottle which manufactured by Smilax Healthcare Pvt. Ltd., Batch No.- 071216- SBE, Exp. Date Nov-2018 form into one Black colour Bag (ii) One Black color Yamaha RX-100 Motor-cycle bearing registration no. BR 20A 9534, Engine No. 1 L 1-289866, Chasis No. 1 L 1-289866 from the possession of above noted Accd. person and Samu Kandu S/O Gangua Kandu of near Jhalda Municipality Office, P.S- Jhalda, Dist- Purulia. I do here by lodged a written complaint against the above noted accused person to the effect that on 28/07/17 at 20:15 hrs received a telephonic information from my source that two persons are coming from Jhalda Hatbagan through Purulia Ranchi road towards Jhalda Bus stand with huge quantities of drugs with them which comes from Jharkhand side. After received such type of information myself along with force who were performing evening mobile duty rushed through Ranchi road and as per information of my source I detect two persons with one motorcycle just arrived in front of Annapurna Medical Store, seen the Police party one person able to flee away and after hot chase we able to apprehended one person and on search we found 45 Pcs of Cough Syrup in a black colour School bag with proper chain. On asked he failed to produce any valid document or license in respect of said Cough syrup. He also disclosed that he transport this cough syrup with intent to sell out at Annapurna Medical Hall and other peddler also for huge profit. On close interrogation he disclosed his name and address as noted above and also disclosed that another one who fled away from their with huge quantity i.e. 90/100 bottles of Cough Syrup with him who namely Samu Kandu S/O Gangua Kandu of near Jhalda Municipality Office, P.S- Jhalda, Dist- Purulia. So I seized the above noted Cough syrup and Motor-cycle under proper seizure list duly signed by the witnesses as well as the apprehended person and also prepared label with seal one bottle of COSCODIN-T syrup as sample. I arrested the apprehended accused person for violating the sec. 27 of drugs & cosmetics Act 1940.

I therefore pray before you to start a case against the two accused persons namely (i) Sk. Abdul (22 Yrs.) S/O Sk. Asrab of Vill- Hossendih, P.S- Jhalda, Dist.- Purulia and (ii) Samu Kandu S/O Gangua Kandu of near Jhalda Municipality Office, P.S- Jhalda, Dist- Purulia under sec. 27 of drugs & cosmetics Act 1940 and arranged for its investigation.
