Sir,

In producing here with nine arrested accused persons including female namely (1) Chittaranjan Mahato (32) S/o-Bhadrachand Mahato of Vill-Bangram, PS-Joypur, Dist-Purulia (2) Narayan Auddy (45) S/o-Li Pruthal Auddy of Vill-Bangram PS-Joypur, Dist-Purulia (3) Dokkharan Majhi (28) S/o-Kundan Majhi of Vill-Nirmalkari, PS-Chandankhars, Dist-Bokaro (4) Karal Mahato (45) S/o-Bisnu Mahato of Vill-Bangram, PS-Joypur, Dist-Purulia (5) Jansai Mahato (40) W/o-Masohar Mahato of Vill-Ramsadh, PS-Joypur, Dist-Purulia (6) Anka Mahali (40) W/o-Madhu oi Madhusudan Mahali of Vill-Selani PS-Joypur, Dist-Purulia (7) Shyamali Mahato (32) W/o-Li Bhabu oi Bhobanath Mahato of Vill-Bangram PS-Joypur, Dist-Purulia (8) Bhabani Mahato (30) W/o-Nilkanth Mahato of Vill-Kathantari PS-Joypur, Dist-Purulia (9) Ranobhara Mahato (42) S/o-Li Ramswar Mahato of Selani, PS-Joypur, Dist-Purulia under proper arrest memos and inspection memos with seized articles (i) Bamboo stick measuring about 4' to 3'-12 pieces (ii) Broken CS bottle-08 pieces (iii) Broken Beer bottle-08 pieces (iv) Broken plastic can-06 pieces (v) Broken one strand of table fan (vi) Bricks of broken boundary wall of liquor shop (vii) Torn register (viii) Torn carton under proper value list to lodge a complaint against above noted arrested accused persons and 700 / 800 unknown persons. To the effect that on 01/07/17 at about 15:05 hrs I am performing patrolling duty with C-924 Santosh Mahato, C-179 Balaram Mandal, C-581 Tanmay Chatterjee, CD-697 Anshu Banerjee vide Joypur PS CC No-2388 dt-01/07/17 and GDR No-07 dt-01/07/17 on Purulia-Bokaro main road. At that time I received an information that 700 to 800 male & female persons are going to demolish newly sited two licensed liquor shop (1) Chas more FL OFF shop at Partard, moora Baragram on Bangram Selani pitch road under Joypur PS (proprietor-Jagadish Ch Mandal) and (2) Bartard U.S ON shop at Partard, moora Ramsadh on Bangram Selani pitch road under Joypur PS (proprietor-Surentha Prasad Sabui). I rushed to the spot to work out the information. At about 15:15 hrs when I reached near the spot found that agitated mob comprising of 700 / 800 male & female, some of being armed with Lathi have started to ransack the aforesaid liquor shops which were about 200 mts away from each other. We tried our best to restrain them but in vain as they were 700 / 800 numbers and we are only four. They obstructed us and even started scuffling with us and trying to push back us from the spot with a gesture of assault by Lathi. Then and there I informed the matter to IC Joypur PS with a request to come to the spot and to arrange reinforcement immediately. At about 15:55 hrs IC Joypur along with fifteen Police personnel, officers & force including lady Police arrived at the spot, till then the agitated mob were continuing their illegal/criminal activities. So IC Joypur PS declared the mob as unlawful assembly and ordered them to disperse within five minutes and subsequently SDPO Bhalda with twenty five Police personnel including lady constable reached at spot. As the mob was not disperse then. Having no alternative way, we chased and applied minimum force to disperse the mob. In the mean time we apprehended above noted five male & four female persons as they are committing criminal activities in presence of Police. At that time of retreat some of them looted some materials from the both of the above noted liquor shops and managed to flee away. As they are committing offence punishable U.S-147/149/186/153-448/427/380 IPC, I arrested nine apprehended persons after maintaining all formalities and informed. Then I search both PO and its surroundings and seized above noted articles from there as annex of this case.

I am to note here that as at the time of occurrence men from the both liquor shop fled away due to fear, though huge quantity of materials have been damaged and looted away from both of the liquor shops whose amount could not ascertain at this time. However I took the photograph of the PO. I therefore pray you to start a case against arrested accused and 700 / 800 others male & female under proper section of law and arrange its regular investigation.
