

In producing here with one accused person namely Manu Gope @ Bhola (28) S/o Sauru Gope of Damru PS Joypur Dist Purulia with one seized arms & ammunition as per seizure list. I ASI Sankar Brahma of Baglata I/C under Joypur Dist Purulia do hereby lodge complaint against Manu Gope @ Bhola (28) S/o Sauru Gope of Damru PS Joypur Dist Purulia to the effect that today (03.07.17) in between 23:25 hrs to 00:45 hrs in course of night mobile duty acting on a "tip off" myself along with C/ 242 Arun Ch. Kumar C/542 Subodh Pain & C/ 1057 Albinash Tirkhey , left for Ropo Hattala bazar side and keeping the vehicle at a distance. I made contact with source and as shown by him we identify one suspicious above noted person, loitering aimlessly at and around in front of grocery shop and customer point of Allahabad Bank at Ropo bazar. We got closer after briefing accompanying constables and in an opportunity moment we gharrood him and managed to apprehended him. On being asked he disclosed his identity as noted above. On search him we found one improvised fire arms loaded with one round live cartridge on his back side waist in side wearing full paint. On being asked he failed to produce any document in respect of carrying and possessing the said fire Arms and Ammunition. So I seized the said fire Arms (Improvised pipe gun length approx 9 ½ " including barrel loaded with one round live cartridge) being prepared proper seizure list. On further interrogation he failed to give any satisfactory answer for being present there at such dead hrs of night with said fire arms. As such there is sufficient reason to believe that the said accused came to that place with an ulterior motive. So I arrested him and on return at Baglata I/C , I submit my written complaint before D/C Baglata I/C with a request to start a case and take law full action accordingly.


