
SI Palash Kr. Barik, O/C Kotshila P.S. do hereby lodge the complaint against Chandi Karmakar (Male/26 Years), S/O- Late. Khedan Karmakar of Vill- Rigid, PO- Rigid, PS- Kotshila, Dist-Purulia to the effect that on 24.07.17 at 16:35 hrs received a credible source information from my source that one Chandi Karmakar, S/O- Late. Khedan Karmakar of Vill- Rigid, PO- Rigid, PS- Kotshila, Dist-Purulia was engaged in the business of stolen motor cycle and at present he accumulated some stolen motor cycle in his house at Village- Rigid, PS- Kotshila, Dist-Purulia. This refers Kotshila P.S. GDE No-1022, Date- 24.07.17. To work out the source information, myself along with force namely I) C/793 Prasanta Patra II) C/863 Rupchand Paoria III) C/689 Prabhas Mahato vide Kotshila P.S CC No-2229/17, Dtd: 24.07.17 held raid in the house of Chandi Karmakar, S/O- Late. Khedan Karmakar of Vill- Rigid, PO- Rigid, PS- Kotshila, Dist-Purulia. On searching we found Two (02) Motor Cycles and asked him to show the relevant papers in respect of that Motor Cycles, but he failed to produce any valid documents in respect of those motor cycles. During interrogation he confessed that he along with one Bikash Karmali @ Sahil S/o-Santosh Karmali of Gorla, PS- Jhalda, Dist-Purulia, A/P-Kedla, No-15 Colliery, PS-Mandu, Dist-Ramgarh (Jharkhand) and some others habitually deal with the business of stolen motor cycles in a clandestine manners since last 3-4 years. I seized and labelled the following Motor Cycle through proper seizure list in presence of available witnesses:-

1. PASSION PRO, Engine No- HA10EVFHE0692, Chassis No- MBLHA10BSFHE05956, Reg. No attached with vehicle- JH 01BS/7999.
2. SPLENDER PRO, Engine No- HA10ELD9C00351, Chassis No- MBLHA10ASD9600773, Reg. No attached with vehicle- JH 09P/4240.

I arrested Chandi Karmakar (Male/26 Years), S/O- Late. Khedan Karmakar of Vill- Rigid, PO- Rigid, PS- Kotshila, Dist-Purulia after informing the ground of arrest and informed his family member and issued memo of arrest.

On return to P.S I registered the case Suomoto U/S- 413/414 IPC against accused Chandi Karmakar (Male/26 Years), S/O- Late. Khedan Karmakar of Vill- Rigid, PO- Rigid, PS- Kotshila, Dist-Purulia and endorsed the case to SI Bansidhar Mukherjee for investigation and handed over all connective papers in c/w this case i.e. Arrest Memo, Seizure List etc. along with seized articles.
