In producing herewith one accel. Person namely Hulet Mahato (28) S7D: Sagar Mahato of Kochahatu. P.S. - Kotshila: Dist - Purulia with seizure of 60 (Sixty) scaled bottles of 80 UP Country Spirit "DILKHUS" & each Bottle contains 600 mLuhich was seized under proper seizure list.

I beg to submit that today (09.07.17) in between 07.05 hrs to 07.25 hrs a raid was conducted in the Tea Stall of Bulet Mahato (28) S/O- Sagar Mahato at Kochahata village under Kotshila P.S. Dist.—Purulia, on acting of secret source information against illegal stock and selling of liquer of the above noted articipated place and found that the above noted person was keepine "selling Country Spirit which was kept in Tea Stall. On demand he failed to produce any talid documentary authority in project of selling of liquer from the house. As such he was arrested us 67 B.E. Act and also seized 60 (Sixty) scaled bottles of 80 UP Country Spirit "Dill KHUS" containing 600 ml, each (60 Bottles v 600 ml= 36 Ltrs.) & of Rs-30/- each (Total Rs-60x)0= Rs-1800/- which was seized under proper seizure list in, u/s 67 B.E. Act which enclosed here with. Out of 60 (Sixty) scaled bottles one (600 ml) sealed bottle taken out as sample with scaled & labeled. During arrest the ground of arrest was duly notified issuing arrest memorals 50 Cr.P.C. and handed a copy of the same to arrest.

The above noted arcsted aced, namely Bulet Mahato (28) S/O- Sagar Mahato of Kochuhatu, P.S. Koshila ISst. Furulia Committed offeree u/s/46A (c) B.E. Act. 1909 for un-authorized procession and sale of country spirit from his Tea Stall.
