Respected Sir,

In possessing herewith one accid. person namely Dhananjay Sen (S/O Lt Prankrishna Sen of - Bagunkuder, P.S. - Kotshila Dist - Purulia with seizure of 62 (Sixty-two) sealed bottles of 80 up country spirit "DHUKHUSH" containing 600ml each & @ rs/- 30 of each bottle.

I beg to submit that today (15.07.17) in between 07.05 to 07.25 hrs a raid was conducted in the snack shop of Dhananjay Sen - S/O Lt Prankrishna Sen of - Bagunkuder, P.S. - Kotshila Dist - Purulia. In course of my night mobile duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in snack shop. On demand he failed to produce any valid document of concern authority in respect of selling/keeping of liquor of the snack shop. He was committing such illegal act in presence of police person. As such he was arrested u/s-67 B.E. Act and also seized 62 (Sixty-two) sealed bottles of 80 up country spirit "DHUKHUSH" containing 600ml each & @ Rs/- 30 each total value of Rs 62X30= 1860/- which was seized under proper seizure list in presence of witnesses duly signed by the accused person u/s- 67 B.E. Act which enclose herewith out of 62 (Sixty-two) sealed bottles one (600ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified to the accid. Person and issuing arrest memo u/s- 50 Cr P.C. and a copy of the arrest memo handed over to the accid. Person.

The above noted arrested accid. namely Dhananjay Sen - S/O Lt Prankrishna Sen of - Bagunkuder, P.S. - Kotshila Dist - Purulia, committed offence u/s- 46A (c) BE Act 1909 for unauthorized possession and selling of country spirit from her snack shop.

It may note here that during raid (01) C/985 Lakshmtan Ch. Majhi, (02) C/ 1220 Ajit Kamli (03) C/516 Chandra sekhar Mahato accompanied me. Vide C.C. No. 2106/17

Under the fact and circumstanced I therefore pray a case u/s 46A (c) B.E. Act. 1909 may kindly be started against Dhananjay Sen - S/O Lt Prankrishna Sen of - Bagunkuder, P.S. - Kotshila Dist - Purulia.
