Respected Sir,

In producing herewith one accd. person namely - Ashutosh Kumar (48 Yrs) S/O Lt. Bidyadhar Kumar of Vill- Durgu, P.S. - Kotshila Dist - Purulia with address of 37 (Thirty Seven) sealed bottles of 80 up country spirit " DILKHUSH" containing 600ml each & @ Rs/- 30/- of each bottle.

I beg to submit that today (16/07/17) in between 19.25 to 19.55 hrs a raid was conducted in the Tea shop of Ashutosh Kumar (48 Yrs) S/O Lt. Bidyadhar Kumar of Vill- Durgu, P.S. - Kotshila Dist - Purulia in course of my evening nocturnal duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in snack shop. On demand he failed to produce any valid document of concern authority in respect of selling/keeping of liquor of the Tea shop. He was committing such illegal act in presence of police person. As such he was arrested u/s-67 B.E. Act and also seized 37 (Thirty Seven) sealed bottles of 80 up country spirit " DILKHUSH" containing 600ml each & @ Rs/- 30/- each total value of Rs. 37X30=1110/- which were seized under proper seizure list in presence of witnesses duly signed by the accused person U/S- 67 B.E. Act which enclose herewith out of 37 (Thirty Seven) sealed bottles one (600ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified to the accd. person and issuing arrest memo u/s- 50 Cr.P.C. and a copy of the arrest memo handed over to the accd. Person.

The above noted arrested accd. namely Ashutosh Kumar (48 Yrs), S/O- Lt. Bidyadhar Kumar of Vill- Durgu, P.S. - Kotshila Dist - Purulia, committed offence u/s- 46A C BE Act 1909 for un- authorized possession and selling of country spirit from his Tea shop.

It may note here that during raid (01) C/994 Srikanta Khumbhakar, (02) C/963 Rupchand Panja accompanied me. Vide C.C No- 2123/17

Under the fact and circumstances I therefore pray a case u/s 46 A (c) B.E. Act 1909 may kindly be started against Ashutosh Kumar (48 Yrs), S/O- Lt. Bidyadhar Kumar of Vill- Durgu, P.S. - Kotshila Dist - Purulia
