Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sadhan Bauri S/O Chakradhar Bauri of village Kolandi (Manbazar) P.O. Shyam Pur, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07.07.17 at about 01:02 PM, Sri Bijan Bauri, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Hrishraj Mandal SAE, (E), Manbazar CCC
- 2) Somenath Kaha C.M, Manbazar CCC
- 3) Bikram Tudu SAE (E), Manbazar CCC

entered the premises of Sadhan Bauri S/O Chakradhar Bauri of village Kolandi (Manbazar) P.O. Shyam Pur, P.S. Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthoritatively by direct hooking from WSEDC line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected, it was also found that he/she was using the following electrical equipments -

- 1) One water pump (0.5HP)
- 2)
- 3)

out of which we seized the following -

- 1) Approx. 10mts hooking wire & hooking device.
- 2) One switch board with two socket and two switches.
- 3) One 0.5HP water pump with approx 2.5mts wire.
- 4) Approx 5mts section pipe and approx 25mts delivery pipe.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 01:15 PM on dated 07.07.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
