I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Kash Bansi S/O Sankarban Bansi of village Keladi Shyam Pur P.S. Mankalgaon, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07.07.12 at about 12:45 PM in Dejan Bansi Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Kash Bansi S/O Sankarban Bansi of village Keladi Shyam Pur P.S. Mankalgaon, Dist - Purulia and inspected his/her premises and found that he was engaging electricity by direct tapping from WBSEDCL's line unlawfully

During inspection, theft of electricity was found, i.e., his/her was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that his/her was using the following electrical equipments -

out of which we seized the following -
