I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act 2007 to the effect that Kush Bhattacharya,
S/O - Sunil Kumar Bhattacharya, of Village- Kuljanpur, Dist. Purulia, PS- Khagaria Purulia,
Dist - Purulia, has committed theft of Electricity u/s 135(1)(n) of the Electricity (Amendment) Act 2007.

On dated 07.07.12 at about 12:00PM, So Dilipan Bhattacharya, station Manager, Mankalan Customer Care Centre, WBSEDCL along with,

entered the premises of Kush Bhattacharya, S/O - Sunil Kumar Bhattacharya, of Village- Kuljanpur, Dist. Purulia, PS- Khagaria Purulia, Dist - Purulia and inspected his/her premises and found that he was causing electricity by disconnection repairing fittings like ETC, TV, fan, telephone, etc.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly u/s 135(1)(n) was detected. It was also found that he/she was using the following electrical equipments -
