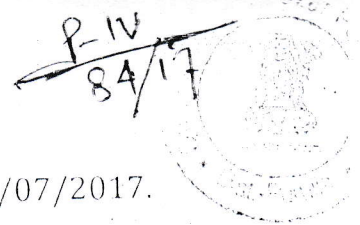

Sir,

I would like to inform you that life convict Jaladhar Sing Sardar S/O Chakradhar Sing Sardar was received from Presidency Correctional Home on 22/10/2010 on the ground of 5 (five) days parole duly approved by ADG (P) & IG of Correctional Services, West Bengal vide his memo No. 1732/PR- 15 (161- IP) dated 14/09/2010.

The said lifer was released on parole on 09/11/2010 upon furnishing a bond by his cousin, Sri Deben Sing Sardar S/O Lt. Gopal Sing Sardar and Smt. Mamata Sing Sardar W/O Sri Deben Sing Sardar of Kuardih, P.S Manbazar, Dist. Purulia. The aforesaid life convict Jaladhar Sing Sardar did not return to Purulia District Correctional Home after availing 5 (five) days parole w.ef. 09/11/2010.

On the basis of enquiry report of S.I Manbazar P.S Sri Uttam Kumar Mondal, it had been learnt that when lifer Jaladhar Sing Sardar accompanied with two sureties, Sri Deben Sing Sardar and Smt. Mamata Sing Sardar was coming to Purulia D.C.H on 15/11/2010, lifer Jaladhar Sing Sardar fled way from Jabla More, P.S Manbazar, Dist. Purulia on 15/11/2010.

The whereabouts of the said convict is still unknown to the Correctional Home Authority.

You are requested to kindly treat this memo as F.I.R and to take legal steps as per existing laws.

Kindly treat this memo as most urgent.

In compliance of the order dated June 13, 2017 a report under memo no 1135/RO dated June 28, 2017 is filed on behalf of the Superintendent of Police, Purulia before us today.

Let the aforesaid report be kept on record.

The following facts have been revealed from the aforesaid report with regard to the availability of one of the appellants, namely, Jaladhar Singh Sardar, son of late Chakradhar Singh Sardar of Village Kuardih, P.S. Manbazar, District Purulia:-

1) The aforesaid Jaladhar Singh Sardar was sentenced to life imprisonment, amongst others, by a judgement and order of conviction dated June 27, 2006 and sentence dated June 28, 2006 passed in Session Trial No. 14 of 2004 by the learned Additional Sessions Judge, Fast Track Court-II, District Purulia.

ii) The aforesaid Jaladhar Singh Sardar was received by the District Correctional Home, Purulia on transfer from Presidency Correctional Home on October 22, 2010 for availing of 5 (five) days



parole granted by the A.D.G. and I.G. of Correctional Service, West Bengal.

iii) The aforesaid Jaladhar Singh Sardar was released from District Correctional Home, Purulia on parole on November 9, 2010 upon furnishing a bond by his cousin, Sri Deben Singh Sardar, son of late Copal Singh Sardar and Smt. Mamata Singh Sardar, wife of Sri Deben Singh Sardar of Kuardih, P.S. Manbazar, District Purulia.

iv) The aforesaid Jaladhar Singh Sardar did not return to District Correctional Home after availing 5(five) days parole with effect from November 9, 2010.

According to the aforesaid report of the Superintendent of Police, Purulia, on November 15, 2010 the aforesaid Jaladhar Singh Sardar fled away from Jabla More, P.S. Manbazar, District Purulia while he was on the way back to Purulia Correctional Home along with his aforesaid surities, Sri Deben Singh Sardar and Smt. Mamata Singh Sardar.

On perusal of the aforesaid report, we do not find any information with regard to the steps taken by the Superintendent of Correctional Home, Purulia consequent upon the aforesaid facts and circumstances.

In view of the above facts and circumstances, the Superintendent of Correctional Home, Purulia is directed to show cause with regard to the steps taken in the matter by way of

filing affidavit before us through Mr. Ranabir Roy Chowdhury, learned State Advocate on the next date of hearing.

The Director General and Inspector General of Correctional Service, West Bengal is directed to implement this order as also to take necessary steps with regard to the failure of the Superintendent of Correctional Home, Purulia to act in accordance with law in the aforesaid facts and circumstances, if it is necessary, as also to file a compliance report before us on the next date of hearing through the aforesaid learned State Advocate.

Heard in part.

Further hearing of this appeal stands adjourned.
