Sub:- Complaint against accident.

Sir,

This is to inform you that on 09/07/17 at near about 3:30 pm when I was travelling from Pundlis to mambasar Jain Mandir in my friends car with my family (India Car- Reg No- WB34E-6393) we met with an accident with a xylor car (Reg No- JH05-AG-8462 WHITE COLOUR) outside on Mambasar-Boro pitch Road at Pathar Mohara near Dain Mandir. The xylor car which was coming from opposite direction at a very high speed, directly came on the wrong side and banged my car from the front. In which my father Gopal Jain who was sitting in the front seat of the car got very badly hurt and injured including other members also. Total fault was of the xylor car driver who came in the wrong side and banged my car at a very high speed.

At that moment I took my father and the family to nearby mambasar hospital for first aid as my father Gopal Jain was badly bleeding. After his first aid Dr at the hospital referred him to Tata main hospital (Sharnadpur) where he died on 11th July, 2017 early morning 7:30 am nearly.

So, I request you to take the necessary action against the xylor driver (Reg No- JH05-AG-8462) and do the needful. Your quick reaction regarding this will be highly appreciated.
