In producing herewith one arrested accd, person namely Jhantu Mandi (28 yrs) S/O- Lt. Kala Mandi of Vill Amsole, PS- Para, District - Purulia with seized article i.e 20 (Twenty) pcs scaled bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample and 04 (four) Lts. of LD Liquor contain a white colour plastic jarican in which approx 375 ml, as sample which were seized under proper seizure list.

I beg to submit that today (30.07.2017) during my Spl. raid duty in between 18.05 hrs to 18.20 hrs acting on a tip off a raid was conducted in the house of Jhantu Mandi (28 yrs) S/O. Lt. Kala Mandi of Vill. Amsole, PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit & ID Liquor which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquors. As such I seized 20 (Twenty) pes sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml and 04 (four) Lts. LD Liquer contain a white colour plastic jarican under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person.

The above noted arrested accd: namely Jhantu Mandi (28 yrs) S/O- Lt. Kala Mandi of Vill- Amsole, PS Para, District Purulia committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act 1909 may kindly be started against Jhantu Mandi (28 yrs) S/O- Lt. Kala Mandi of Vill- Amsole, PS- Para, District - Purulia and arrange for its investigation.
