Sir,

In producing herewith two arrested accd. namely, (1) Majabul Ansary, (32) S/O Lt. Maniruddin Ansary, Villlage Hijuli, P.O. Daldali, PS. Hura, Dist- Purulia (2) Jamani Mahato (28) S/O Lt. Anadi Mahato, Villlage Baghatard, P.O Dapang, PS. Hura, Dist. Purulia with Arrest Memo, Inspection Memo and seized articles viz (1) **one iron made single bore country made fire arms having length of 9 1/2 Inch (approx) with butt, barrel, firing pin, etc. Barrel length 5 1/2 inch (approx), (2) one live ammunition of .303.** (3) One Black and red colour check school beg under proper seizure list and being labeled properly, I beg to inform you that today (23.07.17) at 20:45 hrs, received a telephonic information from my reliable source that two youths namely Majabul Ansary and Jamini Mahata of about 30/32 Years were loitering suspiciously near Koira bridge under Puncha PS and they had a beg with them in which there was a fire Arms. Accordingly I diarised it vide Puncha PS G.D.E No 707 Dtd 23/07/17 and consulted with O/C Puncha PS and as per his direction at 20:55 hrs, I, along with ASI Biswarup Roy and forces, who were on mobile duty started for working out the information (vide CC No 1347/17 Dtd 23/07/17) after briefing them properly about the gravity of the information and my plan to nab them. We reached at Koira Bridge at around 21:25 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching, there we found two youths walking towards Koira village and accordingly we apprehended them and on asked they identified themselves as (1) Jamani Mahato (28) S/O Lt. Anadi Mahato, Villlage Baghatard, P.O Dapang, PS. Hura, Dist. Purulia & (2) Mujabul Ansary, (32) S/O Lt. Maniruddin Ansary, Villlage Hijuli, P.O. Daldali, PS. Hura, Dist- Purulia and we recovered a black and red colour check school bag from the possession of Majabul Ansary and on searching from the bag recovered (1) one iron made single bore country made fire arms having length of 9 1/2 Inch (approx) with butt, barrel, firing pin, etc. length of the barrel is 5 1/2 (approx) and (2) one live ammunition of .303 and on demand they failed to produce any papers in respect of the Fire Arms and Ammunition while searching their bodies nothing could be recovered. Accordingly I seized the same under proper seizure list and on interrogation both confessed their guilt of keeping the same. I arrested them observing all the formalities regarding arrest.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
