I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Srikanta Pandey S/O Dharanidhar Pandey of Vill -Rudra, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 18.07.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E) ,Debdulal Banerjee, Sr.TSH of Telkalpara CCC & Jaur Rahaman Mondal, AE(S&LP) of Purulia Region ,WBSEDCL conducted a raid programme. at village Rudra under Purulia(M) P.S. When our team at about 02.00P.M. entered to the Domestic premises of Srikanta Pandey, we found that he was enjoying electricity dishonestly by means of Meter bypassing by tampering terminal cover and run electric heater & domestic appliances , thus WBSEDCL losses revenue . As theft of electricity was detected in presence of the local witnesses ,service cable & tampered meter and seized and seizure list prepared .The seized material labelled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.30 P.M. after completion of inspection & necessary formalities.

Srikanta Pandey S/O Dharanidhar Pandey of Vill -Rudra, PS -Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
