To The Office-in-Charge Purulia Town PS Rurulia

I do here by lodge complaint producing seized vehicles No.WB55 8401 (in unloaded condition) to the effect that today on 25.07.17 morning received a credible source information to the effect that a vehicle No.WB55 8401 loaded with PDS articles coming from Jhalda side which will go to Jharkhand for clandestine business purpose. Accordingly I noted the fact in GD vide Purulia (T) PS GDE No. 1362 dtd.25.07.17 at 10:45hrs. myself along with officer and force (1) ASI Pranab Tewary (2) WC/461 Tarapada Hazari (3) HG/1427 Benimadhab Char & (4) HG/1525 Phalguni Kumar all of DEB, Purulia left for Patkum house morh on Wilcox road under Purulia(T) PS. After waiting there some time myself observed vehicle bearing Registration No. WB 55 8401 in loaded condition coming from Jhalda side myself gave signal to its driver for stopping the vehicle but the driver violating my signal forwarded in front to some extent and stopping the vehicle, the driver and his assistant fled away. Then myself searched for the driver in surrounding area and also wait for him if he come but he did not turn up. The vehicles goods were covered by polythene. After opening one portion of the polythene of the detained vehicle it came to my knowledge that the vehicle loaded with bags of Atta and Rice which belong to Public Distribution commodities. I thereafter informed my superior and sub-divisional controller, Food & Supply over phone seeking their necessary assistance. As it was raining heavily and finding no other alternative I took the detained loaded vehicle to Bhagabandh i.e. shop cum business place of one Deb Kumar Dan, local MR distributor of Purulia Town, with help of other driver, for taking the help of such MR distributor for completion of follow up actions. In the meantime I also asked two local witnesses to assist us namely (1) Md. Akbor s/o Lt. Md. Basir and (2) Md. Pappu s/o Lat. Md. Seru both of Kasai Mahalla Ward No.8, PS Purulia(T). At the godown of Deb Kumar Dan we opened the cover of goods under covered roof in presence of independent witness and also in presence of staff of Food & Supply namely (1) Hirak Bhattacharjee, Inspector, F&S (2) Nilanjan Dey, SI, F&S, Purulia those Food & Supply officers identified the goods as of PDS articles and they made weighment chart and submitted written report in this regard. Then I seized the following articles under proper seizure list in presence of witnesses (1) one vehicles bearing Registration No. WB 55 8401 (2) Rice-37 No of stitched bags weighing 18.13 Qtls @ 49Kg/bag (3)

Fortified Atta- 64 Nos. of stitched bags weighing 31.36 Qtls @49 kg/bag Sl. No. (2) & (3) were loaded in Sl. No.(1). It is reasonable to believe that the driver and his associates in connivance with some others made conspiracy to sell the PDS goods in open market at high price depriving the poors and needy card holders of BPL & AAY and the accd. persons made criminal conspiracy to make such type of unlawful activities and there by tried to create and artificial crisis among the poor people of the society after forming an illegal business racket. Hence those driver of vehicle No. WB 55 8401 and his associates committed an offence punishable u/s 7(i)(a)(ii) of E.C.Act 1955 read with sec 120B IPC for violating the provisions as mentioned in Government Notification No.2347-FS/Sectt/Food/4P-09/2012 dtd.08.08.2013 under the West Bengal Public Distribution system (Maintenance & Control) Order, 2013.

Hence I request you to start a case u/s 7(i)(a)(ii) of E.C.Act 1955 read with sec 120B<sub>e</sub>IPC against the accd. Driver of vehicle No. WB 55 8401 and his associates. All the seized PDS goods (except vehicle) are given in Zimma of one Deb Kumar Dan s/o Lt. Shyam Sundar Dan of Bhagabandh, PS Purulia(T). Owner of Mrs. Shyam Sundar Dan, MR distributor, Purulia after taking proper zimmanama.

As per order of Dy.SP(DEB), Purulia SI Sajal Mishra of DEB, Purulia will investigate the case.
