Sir,

Respectfully, I, namely, Umesh Kumar Kashyap,
Sub-Divisional Disaster Management Officer, Jhalda Sub-
Division, Purulia, my permanent address being S/o Late
Raj Kishore Pasad, Tebri Teli near Namkum Railway
Station, H.T.I.F. Co-operative Colony, Namkum, Ranchi
and present address ^{being} Flat no. C/96, R.H.E. (Housing),
Ranchi Road, Purulia ^{being} to inform you that I heard
over telephone from my neighbors that on the night of
22.07.2017 some miscreants had broken the locks
of my flat no. C/96 and room and an incident of theft
had taken place. I was ^{at} that time at Ranchi (Jharkhand)
with my family members. After ~~be~~ listening to this
message on the morning of 23.07.2017, I rushed to
Purulia and reached my flat at about 12.45 P.M.

After reaching my flat, I talked to Police station and
after being instructed to look into the materials to assess the
theft materials, found that Almirah of the bed room was
broken and almost all materials ~~were~~ like, clothing, files/
documents etc. ^{were} lying on the floor. Further, I found
missing the following items/materials from my house as a
result of the incident of this theft:

- (i) Ornaments, Jewelleries made up of gold and silver -
- (ii) Necklace - 04 (four) nos. made up of silver ~~with~~,
Some with gold plating.
- Nose rings - 04 (four) nos made up of gold.
- Foot finger rings - nearly 40/50 nos. made up of silver.
- Golden locket of Mangal Subia ~~was~~.
- Payal (Nupur) made up of silver - 04 (four) nos.
- cash approximately Rs 10000.00 (Tenthousand)
including money boxes of coins.

I have heard from the neighbors that similar types
of incident of thefts have taken place on the same night
