Entered the premises of Biswajit Banerjee, S/o- H. Sadhan Banerjee, Vill Wandurra Banerjee pura
P.S. Raghunathpur, Dist- Purulia, having Consumer No. 242232833. Meter No. H34.9194
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 04 nos.
- 2) Electric water pump - 01 no.
- 3) CFL Bulb - 04 nos.
- 4) Freeze - 01 no.
- 5) TV - 01 no.

Out of which I seized the following.

- 1) Cutting/Tampered portion of incoming service cable - 1 ft' (Approx).
- 2) Connecting cable for by pass arrangement - 15 ft' (Approx).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 2:30 PM on 27/07/17. The accused person has committed an offence
U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be
taken as per rule.
