In producing herewith the arrested accused person Lob Majhi (55) s/o Lt Sambhu Majhi of Hansapathar, PS - Neturia, Dist - Purulia, driver of truck No. WB 15C/4609 loaded with stolen coal approx 16 MTs with above noted vehicle. Fact of the case in brief is that on 11.07.17 myself along with C/1412 Sasanta Patra and C/129 Hanupada Rajwar who were on evening mobile duty on Raghunathpur - Santaldih road and received a source information that the above noted vehicle is coming loaded with coal from Santaldih side towards Raghunathpur side. After receiving this information we had been to Raghunathpur - Santaldih road near at Manogram Rly. Gate and found that the above noted vehicle loaded with coal is coming from Santaldih side. We stopped the said vehicles and asked the driver to produce the authentic papers in respect of said coal as well as papers in respect of his vehicle but he failed to produce the papers. The driver also confessed his guilt implicating himself and owner of the said vehicle who were involved into this case. The driver also stated that they are running a clandestine business through this coal for wrongful gain and they are habitual to running this business. As such it is every reason to believe that the driver, owner of the said truck No. WB 15C/4609 with ill motive were transporting coal illegally and they are liable for offence punishable U/S 379/411/413/414 IPC. As such I arrested the accused driver of above noted vehicle after observing all formalities regarding his arrest. On interrogation he disclosed his identity as noted above. I also seized the truck No. WB 15C/4609 loaded with approx 16 MTs Coal under proper seizure list duly signed by the accused driver and witnesses. No public witness was available there.

I therefore pray that kindly start a case against accused person Lob Majhi (55) s/o Lt Sambhu Majhi of Hansapathar, PS - Neturia, Dist - Purulia and owner of the truck bearing No WB 15C/4609 as per law and arrange its investigation.
