Sir,

In producing herewith 03 arrested accused persons namely (1) Bablu Barui (30) s/o Malay Barui of Vill.- Simra, PS - Raghunathpur, Dist - Purulia, (2) Madan Mallick (27) s/o Kalipada Mallick of Do and (3) Rajen Bauri (26) s/o Jiban Bauri of Vill.- Nanduka, PS - Raghunathpur, Dist - Purulia with following seized articles (1) One fire arms loaded with one round live cartridge, (2) One round live cartridge, (3) one small torch light, (4) One hacksaw blade and (5) One red colour nylon rope approx 20 ft. that today (18.7.17) at 20:45 hrs in course of my evening mobile duty (vide Raghunathpur PS GDE No 794 dt 18.0717, CC No 2787/17 dt 18.07.17) I received secret information from a source that a gang of criminals comprising of 5 heads under the leadership of accused Bablu Barui, assembled near at Mangalda Jore (under Raghunathpur PS) being with fire arms and other articles etc with a view to commit dacoity in Raghunathpur - Chelliyama Road.

Accordingly I informed the matter to O/C Raghunathpur PS, over phone and briefed to all my accompanying force. I immediately along with source and C/38 Parbati Ch. Mudi, C/1429 Jagadish Mahato left for to work out the information with Govt. vehicle No WB 56C/6223. At 21:15 hrs we reached at Mangalda Jore where the accused were assembled and preparing themselves for committing dacoity. From distances of about 50 mtrs. we ambushed there. Their whispering came to our knowledge regarding committing of dacoity in the said road. We crawled nearer to them and disclose our identity and asked them to surrender; at that time, they all started to flee away, we chased them by using dragon light device. After a hot chase we could able to apprehend (1) Bablu Barui (30) s/o Malay Barui of Vill.- Simra, PS - Raghunathpur, Dist - Purulia, (2) Madan Mallick (27) s/o Kalipada Mallick of Do and (3) Rajen Bauri (26) s/o Jiban Bauri of Vill.- Nanduka, PS - Raghunathpur, Dist - Purulia, as identified on interrogation and 02 (two) others were fled away but on several interrogation the above noted arrested did not disclose the identity of other 02 (two) accused persons. On further interrogation they stated that they along with 02 (two) others were assembled there and preparing themselves for committing dacoity in Raghunathpur - Chelliyama road. We searched the above persons and following items were recovered from their possession, as (1) One fire arms loaded with one round live cartridge and another one live cartridge from the possession of Bablu Barui, (2) One small torch light from the left hand of accused Madan Mallick and (3) One hacksaw blade and one red colour nylon rope approx 20 ft. from the possession of accused Rajen Bauri. On demand, they failed to give any satisfactory explanation in respect of their presence in this area in that time with such deadly weapons. So it is crystal clearly that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 399/402 IPC & 25/27 Arms Act. As such 21:45 hrs to 21:55 hrs on 18.07.17 the above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons. As no public witnesses were present at the abandoned area thus seizure list was signed by the accompanied officers and force.

On return to PS, I lodge complainant against (1) Bablu Barui (30) s/o Malay Barui of Vill.- Simra, PS - Raghunathpur, Dist - Purulia, (2) Madan Mallick (27) s/o Kalipada Mallick of Do and (3) Rajen Bauri (26) s/o Jiban Bauri of Vill.- Nanduka, PS - Raghunathpur, Dist - Purulia & 02 others for starting a case as per law and also for arranging its investigation.
