Respected Sir,

In producing here with arrested accused persons namely (1) Kundu Byad (34 yrs) S/O-Lt. Ashok Byad of Vill- Dhulamakha (Kalali) Basti, PS-Hirapur, Dist-Paschim Burdwan (2) Ajoy Byad (26 yrs) S/O-Lt. Bachan Byad of Vill - Dumarakuli, PS - Raghunathpur, Dist - Purulia and (3) Sona Byad (21 yrs) S/O-Ramlal Byad of Vill-Jagadih, PS-Asansol (South), Dist- Paschim Burdwan along with seized one improvised country made Fire Arms loaded with one live 0.8 mm Cartridge, one Crowbar, one Sword, one Rod, one Fighting Punch, one Torch Light & Two (02) empty bottles of Country Liquor brand of "Captain". I leg to lodge this complaint against the said arrested accused persons and his associates (1) Uttam Bour of Vill-Ituri, PS-Saltora, Dist-Bankura & two others who were manage to fled away to the effect that today at about 18:25 hrs I received a credible source information that a gang of dacoits assembled at the back side area of a abandoned room near Vikash Metal Factory main gate which situated just beside the Saltora - Sarbari road. He also informed me that they are preparing themselves for committing a dacoity at "Poradiha Bharat Petrol Pump" near Poradiha Morh. Accordingly, I noted the fact in G.D. vide Santuri P.S. GDE No. 747/17 Dtd: 18.07.17 and informed the matter to O/C Santuri P.S. Thereafter, along with ASI Sanat Kr. Mondal and force (C/634- Sakti Pada Orang, C/716 Achintya Majee, C/823 Swapn Kr. Barik, JC 1277 Nabakanta Sing and CD-1159 Jayanta Konar) left P.S. to work out the said source information after obtain permission from O/C Santuri P.S. vide Santuri P.S. C.C. No. 2630/17 Dtd: 18.07.17 by Govt. vehicle bearing No. WB 24/7332.

Then, we stopped our vehicle by the side of road keeping approx 100 meters distance from Vikash Metal Factory main gate. After that, we gradually approached at the back side area of said abandoned room near Vikash Metal Factory main gate (place of assembly of the criminals) as indicated by the source hiding ourselves in the darkness of the bushes and avoiding any type of sounds. We slowly and carefully advanced nearer to the spot taking advantage of the darkness of the bushes from where miscreants were clearly visible and their whispering also audible to us. We noticed that they were preparing themselves to commit a dacoity at "Poradiha Bharat Petrol Pump" near Poradiha Morh under Santuri PS. After approaching towards them from a considerable distance, we confirmed that a gang of 06 (Six) miscreants assembled there and making preparation for committing dacoity in the said Petrol Pump at night. Thereafter, we quickly surrounded the place of assemble from all the side and loudly disclosed our identity. Accordingly, they started to run but after a hot chase we manage to apprehend 03 (three) miscreants out of 06 (Six) miscreants. As such there is no locality nearby; we failed to bring any public witness.

Then, I interrogate them one by one where they disclosed their identity as noted above and also confessed that they were really assembled there for making preparation with a view to commit dacoity at the said Petrol Pump being armed with Fire Arms and other offensive weapons. During interrogation, they disclosed the name of 01(one) other associates as (1) Uttam Bouri S/O - Nandalal Bouri of Vill-Ituri, PS-Saltora, Dist-Bankura out of 03 (three) who were manage to fled away. Accordingly, I arrest them after prepared proper arrest memo and after observed all the rules & norms of arrest. Then, we started to search each criminal one by one and recovered the following offensive articles from their exclusive and respective possessions as described below:-

- i. One improvised iron made country made fire arms loaded with one 0.8 mm cartridge fitted with Butt, Body, Barrel, Trigger, Firing Pin, having length 20.8 cm (approx), Butt to Body 13 cm (approx) and Barrel 12.6 cm (approx) which recovered & seized from the exclusive possession of accd. Kundu Byad found kept conceal inside the pant at waist position.
- ii. One Crowbar having length of 77 cm (approx) seized from the exclusive possession of accd. Ajoy Byad.

iii. One Sword fitted with handgrip having length of 78 cm (approx) seized from the exclusive possession of accd. Sona Byad.

Then, we asked them to produce the valid license or documents in respect of possessing and carrying such fire arms as per provision of Arms Act-1959 but all of them failed to produce any valid license or documents in respect of carrying and possessing the fire arms. Hence, it is reason to believe that they were possessing and carrying such fire arms illegally for offensive work. Hence, I seized all the same as noted above after prepared proper seizure list duly signed by the witnesses and accd. persons after making proper label.

Apart from that I seized the following articles as Alamat of this case-

- i. One iron made rod having length approx 44 cm.
- ii. One one steel colour Torch light.
- iii. One Fighting Punch.
- iv. Two (02) empty bottles of Country Liquor brand of " Captain" from place beside them.

All the above noted articles have been seized under proper seizure list duly signed by the witnesses and accused persons. The process of search, arrest and seizure commenced at 19:35 hrs and completed at 20:45 hrs.

I like to note here that during arrest all the arrested accused persons were well informed regarding cause of arrest, copies of arrest memo & seizure list has been supplied to them.

The above noted arrested accused persons and their associates were came there with unauthorized improvised fire arms, Crowbar, Sword, Iron rod & Fighting Punch for committing dacoity at "Poradiha Bharat Petrol Pump" and they liable U/S 399/402 I.P.C. read with sec. 25(1-A)/27/35 Arms act.

So, kindly start a case against all the 06 (Six) accused persons (1) Kundu Byad (34 yrs) S/O-Lt. Ashok Byad of Vill-Dhulamakha (Kalali) Basti, PS-Hirapur, Dist-Paschim Burdwan, (2) Ajoy Byad (26 yrs) S/O-Lt. Baclan Byad of Vill - Dumarakuli, PS - Raghunathpur, Dist - Purulia, (3) Sona Byad (21 yrs) S/O-Ramlal Byad of Vill-Jagadih, PS-Asansol (South), Dist- Paschim Burdwan, (4) Uttam Bouri S/O - Nandalal Bouri of Vill Ituri, PS-Saltora, Dist-Bankura and 02 (Two) others and arrange its investigation.


