Suddly one person I noticed that he was following me from backward. But near Bijoy's house he grabed my neck with a mylone Rope from my back, then we both were fell down, I shouted loudly so, the guy and his partners left my and friend from that place.

Sir, I have a strongly belived that, one person to whom I gave him money for his personal Cause Rs. 1,94,000. The name of the person is, Dipak Das, <sup>his address: Near Kuli Grove Adra.</sup> I belived that due to this Cause he was trying to Kill me and he was preplanned about this incident to do.

My request to you, please take kindly step and save my life for future.
