I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Bhagbat Kumar, S/O- Sri Umasadhu Kumar of village Karun, P.O- Karun, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 19/08/17 at about 11:40 a.m. Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Abdul Harib, LM 2. Sajal Kumar Mahant, OE 3. entered the premises of Sri Bhagbat Kumar, S/O- Umasadhu Kumar of village Karun, P.O- Karun, Dist- Purulia and found Sri Bhagbat Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Bhagbat Kumar S/O- Sri Umasadhu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Abdul Harib, LM 2. Sri Sajal Kumar Mahant, OE The inspection team left the premises at 11:55 a.m.
