I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Balaram Kumar, S/O Sri Premchand Kumar of villege Jhabri, P.O. Uthandih, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 19/08/2017 at about 12:20 p.m I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Abdul Harib, LM 2. Sajal Kumar Mahanta, OE 3. \_\_\_\_\_ entered the premises of Sri Balaram Kumar, S/O Premchand Kumar of villege Jhabri, P.O. Uthandih, Dist- Purulia and found Sri Balaram Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Balaram Kumar S/O- Sri Premchand Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Abdul Harib, LM 2. Sri Sajal Kumar Mahanta, OE The inspection team left the premises at 12:30 p.m.
