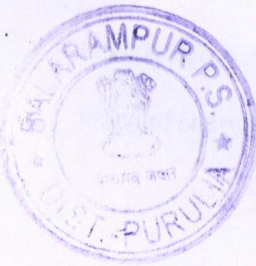

Sub: Lodging F.I.R against Md. Kayes, S/o. Selim Hasmi for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Md. Kayes, S/o. Selim Hasmi resides at Old Hospital Road, Balarampur, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information today on 04.08.2017 from 2.05 PM to 2.30 PM I, along with Jiaur Rahaman Mondal, A.E. (S&LP), Purulia Region, Sri Samar Kr. Pandey, (Retd. D.S.P), S.O (S&LP), Purulia Region, Sri Anup Mandal, S.A.E, Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Md. Kayes and held raid.

During raid and inspection it was detected that accused Md. Kayes is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1No. Lamp & 1 No. drill machine . having connected load 0.23 KW

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line from our LTOH line. Accordingly they disconnected the aforesaid the aforesaid hooking line from LTOH Line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over to the accused.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
