Respected Sir,

In producing here with arrested accused namely Uttam Barman S/O- Madhusudhan Barman of Vill.+P.O.- Aymabarbariya, P.S.- Pataspur, Dist.-Purba Medinipur A/P Balarampur Bus stand, P.S.- Balarampur, Dist.-Purulia along with seize articles as per seizure list . I beg to report that yesterday at 16:05 hrs. received a telephonic information that some villagers of Baghdadih village under Balarampur P.S. detained the above noted accused person with approx 05 (five) Kg rice in a bag. They detained the accused with a believe that he procured the rice by theft from Baghdadih Uppar Primary School from the stock of Mid Day Meal. On the basis of this information myself along with force reached near Baghdadih Uppar Primary School and found the above noted accused person detained by the local villagers. On search found approx 05 (five) Kg of rice in bag, on being asked he failed to give any valid documents in support of said rice and he clearly admitted that he committed theft rice from the Mid Day Meal. I seized the rice from the possession of above noted accused person after repairing proper seizure list duly signed by the accused person and witnesses. It is reasonable to believe that he procured the said rice committed theft from the Mid Day Meal of Baghdadih Uppar Primary School.

I arrested accused the above noted accused person namely Uttam Barman S/O- Madhusudhan Barman of Vill.+P.O.- Aymabarbariya, P.S.- Pataspur, Dist.-Purba Medinipur A/P Balarampur Bus stand, P.S.- Balarampur, Dist.-Purulia after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with seized article.

Therefore I pray that a specific case may kindly be registered against the above noted accused person under proper section of law.
