Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect that Shri Haripada Mahato S/O Matilal Mahato of VILL-Palma was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 21.08.2017 I, Sri AMIT SING, S.A.E & S.M., BARABAZAR CCC along with

- (1) JALAD BARAN GHOSAL, L.M, BARABAZAR CCC, WBSIEDCL
- (2) JAGABANDHU MAHATO, HG.T.S.H, BARABAZAR CCC, WBSIEDCL

Entered into the premises of HARIPADA MAHATO, S/O MATILAL MAHATO of VILL-PALMA and inspected his premises at Vill- PALMA, P.S- BARABAZAR, DIST- PURULIA at 1:40 p.m..

During inspection, it was found that HARIPADA MAHATO S/O MATILAL MAHATO of VILL-PALMA was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at PALMA with the help of single core flexible wire having connected load 0.19 KVA.

From the above arrangement he was using the following equipment:

01. 01 no ceiling fan(60 watt)
02. 01 no bulb (100 watt)

Out of which I seized the following articles:

1. 01 no bulb (100 watt)
2. 02 nos single core PVC flexible wire (each 10 meter approx) with hooking device .

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 2:00 p.m .

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
