




- 1. That the complainant is the legally married wife of accused Hemanta Mahato and their marriage was registered before the marriage register sub-Registry office

  Purulia vide No. 11 of 2005 dated 1.2.2005 and there after their marriage was solemnized on 17.2.2005 according to their customary rites and formalities prevailing in ehrir society. The parties are Hindu by religion. After marriage they lived together as husband and wife at the matrimonial home of the complainant. The marital tie between the complainant and accused person is still subsisting.
- 2. That after marriage the complainant went to her Matrimonial home to discharge her matrimonial life and due to such wedlock a female baby was born who is aged about 10 years.
- 3. That at the time of marriage the mother of the complainant gave Rs, 50,000/= in cash as dowry as per demand of the accused person and she also gave golden ormanemts about 3 bhoris and other utensils furnitures etc, to the accused person as per his demand.
- 4. That after birth of daughter of the complainant the accused persons started to torture upon the complainant physically and mentally and put pressure upon her to bring Rs, 50,000/= as further powry from her mother which the mother of the complainant could not fulfil.





- assault upon the complainant gradually increasing.
  The accused persons started to assault the complainant marcilessly and the supply of food of the complainant was very irregular and even small g quently and he started to forture upon the complainant by various ways both mentally and physically.
- 6. That in such painful circumstances in the last part of January 2017 at midnight the accused persons sprinkhed kerosene oil over the body of the complainant for the purpose of finish her life. By seeing that activities of the accused person the complainant raised alram by saying Banchho, Bancho and hearing the noises the para people came to the spot and they saved the life of the complainant.
- 7. That the complainant informed the matter to the local p.s. but the accused persons undertakes that he will not torture upon the complainant in further but the mind and nature of the accused person could not change.
- 8. That thereafter on the month of Feb. 2017 the accused person mercilessly assaulted the complainant by fist and blow and he drove her out from the house. The complainant finding no other alternative went to her father's house with her minor daughter and she reported the matter to the witness and others.





- 8. That the complainant has informed the matter to the O/C Hura p.s. and she also reported the matter to the S.P. Purulia on 25.4.2017 but till now police did not take any steps against the accused person. So the complainant has been compelled to ficks take shelter before the Ld. Court.
- 9. That the complainant is helpless poor woman and she is not in a position to prosecute the case in her personal capacity and for such reason a police case is desirable.

It is therefore prayed that your Honour may be pleased to sent this petition of complaint to the O/C Hura p.s. to treat the same as F.I.R. and to investigate the same as provided u/s 156(3) Cr.P.C.
