Sub: - Complaint against Kiriti Gope (55) s/o Lt. Batul Gope of Vill- Nischintapur, PS Hura, Dist. Purulia A/P Vill- Lalpur, PS- Hura, Dist- Purulia to start a cog case U/S-46A(c)B.E. Act.

Sir,

In producing here with arrested accused namely Kiriti Gope (55) s/o Lt. Batul Gope of Vill- Nischintapur, PS Hura, Dist. Purulia A/P Vill- Lalpur, PS- Hura, Dist- Purulia along with seized Country Spirit bottles DILSE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 13.08.17 at 18.05 hrs received a credible source information I SI Biswajit Sarkar along with force held raid (19.05 hrs.- 19.50 hrs) in a Sweet Shop of above noted accused person at Lalpur More beside NH 60-A under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit which was kept in his Sweet shop at Lalpur more under Hura PS Dist Purulia, On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses & accd. person and labeled sample two bottles. This is to note here that on seeing police party all public/customers fled away. Total 34 (Thirty Four) bottles country spirit (DILSE) have been seized; Dil Se- 04 (Glass) bottles measuring 600 ML each bottle and value Rs. 30 each and Dil Se - 30 (Plastic) bottles measuring 375 ML each bottle and value Rs. 19. Total value of seized liquor is Rs 690/- (Six hundred ninety only). Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Kiriti Gope (55) s/o Lt. Batul Gope of Vill- Nischintapur, PS Hura, Dist. Purulia A/P Vill- Lalpur, PS- Hura, Dist- Purulia and arrange for its investigation.
