

The complainant above named;

Most respectfully begs to state as follows:-

- 1. That the complainant is a permanent resident of Jhalda Town.
- That the complainant runs a Shoe Shop in the main road of Jhalda under name and style "Tanmoy Shoe Store".







- That the complainant has been in occupation of the said shop as a Tenant under Accused No. 1. It is a single storied building.
- 4. That the Accused No.1 Ramratan Pipuria has threatened to evict the complainant without due process of law, so the complainant has filed Title Suit No. 270/19 _____ in the Court of the Learned Civil Judge (Junior Division), Purulia and obtained order of injunction.
- That accused No.1 as plaintiff filed Title Suit No. 37/15 against the complainant for eviction.
- That Accused No.1 Ramratan Pipuria is the father of Accused Nos. 2 and 3.
- 7. That the accused persons have intentionally damaged the roof by making holes and water falls in the Shop room of the complainant and due to water the Shoes and Chappals as kept on the shop are being damaged. The walls of the shop room are also being damaged.
- 8. That the complainant on many occasions requested Accused No.1 Ramratan Pipuria to close the hole of the roof as he is petty shop keeper and has been facing monetary loss but accused No.1 refused and threatened the complainant with dire consequence to evict him.
- That on the date of occurrence i.e on 05-07-2017 at about 2.00 p.m there was smart shower at Jhalda and due to rain the rain water fell to the shop of the complainant.
- 10. That when the rain became slow the complainant with the help of a WOODEN SIRI tried to go up stair with a view to cover up the hole in



the roof so that there cannot be any further damage of his shoes,
Chappals etc. lying in the Shop room.

- 11. That when the complainant was about to go to roof with the help of SIRI the accused persons came to the spot from their nearby shop room and they dragged the complainant near "Tanmoy Shoe Shop.
- 12. That thereafter Barun Pipuria ordered the other two accused to finish Tanmov and he began to assault Tanmov with fist and blows. Manoi also assaulted the complainant with fists and blows. Barun Pipuria had a Bhoiali in his hand and he with the help of that weapon tried to strike on the head of the complainant. The accused Barun Pipuria with the help of Bhojali striken on the upper part of the forehead of the Complainant on its right side and also hit on the right side and left side of his chest. The Complainant sustained injuries and blood was oozing out when the accused Barun again with the help of Bhojali was about to further assault on the head of the Complainant, Witness No.2 who was in the sShop come out and tried to rescue her husband. She was also heckled by the accused persons. Other witnesses who were present inside the shop to purchase shoes came to the spot and tried to rescue by seeing the witnesses the accused persons left the place. The accused persons with an intention to finish the life of the Complainant assaulted him. Wearing apparels of the complainant was torn. The complainant thereafter had been to Police Station and found that Barun Pipuria was sitting inside the Thana. The Complainant became puzzled and even in presence of Police Officer Barun openly





gave out that he will finish the Complainant. The Complainant was admitted and treated at Jhalda P.H.C. After giving injection and Medicine discharged him and asked him to admit before Purulia. On 06-07-2017 the complainant lodged diary before Superintendent of Police, Purulia and also District Magistrate, Purulia.

- 13. That on 14-07-2017 the Complainant again suffered pain on his chest and he was immediately admitted at Purulia Sadar Hospital for treatment and was discharged on 15-07-2017.
- 14. That the accused persons assaulted the Complainant and also damaged portion of Show-Case of the complainant.
 - 5. That the Jhalda Police have not taken any action against the accused persons as they are very influential persons.
- 16. That the accused persons have committed an offence under Section 325/326/307/447/506 of the I.P.C. The accused persons are s till roaming at Jhalda.

It is therefore prayed that your Honour would be pleased to send this petition of complaint to the Officer-in-Cahrge Jhalda P.S by treating the same as F.I.R under Section 156(3) of Cr.P.C.
