Sir,

Most respectfully I beg to say that I, 54 years of age, am resident of village- Saram, P.S.-Gomia, District-Bokaro (Jharkhand) some 80 Kms north to Jhalda.

On 18.11.2013, I married my eldest daughter- Priyanka Dey alias Sweety with Mr. Ajay Narayan Bit S/O Late Lakhi Narayan Bit by making part payment of demanded dowry amount to Mr. Vijai Narayan Bit and Mrs. Bulurani Bit, elder brother and mother of the groom of Rs. 2.5 lac in cash, furniture etc. worth Rs. 30,000/- and gold ornaments to the groom worth Rs. 70,000/-. The marriage was solemnized at my place as per Hindu rites and custom.

Things were moving well but problem started after the birth of a female baby; named Anushka, on 27.11.2016. My Jamai lives with his elder brother Mr. Vijai Narayan Bit, his widow mother- Bulurani Bit, Indrani Bit W/O Mr. Vijai Narayan Bit in a common house and mess at BagtiPara, Jhalda town having lucrative business. A married sister of my Jamai named Deepali (Bit) Ash with her husband Mr. Tapan Ash at my village.

My Jamai, his mother, started demanding Rs. 2.5 lac as also additional dowry just after the birth of Anuska, in the pretext of keeping the amount in fixed deposit for use of dowry of Anuska's marriage. I being a poor man, could not arrange that big amount, I have to educate and marry another two daughters. In order to get the demanded amount, particularly Bulurani and Indrani Bit, removed their both the maid from service and directed my daughter to carry out all the domestic works including cleaning, cooking. At time, my Jamai used to beat my daughter physically. She was last physically assaulted on 19.07.2017, as she declined to oblige them to get their illegal demand fulfilled.

Mrs. Deepali Ash and Mr. Tapan Ash, had visited Jhalda on 20.7.17 and misled my Jamai by making a false complain against my daughter touching her chastity at village- Saram, by which my Jamai addressed her as bitch in presence of several members of his family which caused a great shock & pain in her mind, getting information of such event, I rushed to Jhalda on 22.07.2017 and protested their objectionable conduct. They all jointly demanded Rs. 2.5 lac and commanded me to take her back for ever. He would divorce her or she may go anywhere or elsewhere.

I, took her home on 22.07.2017 evening she was in great mental shock. We provided all sort of solace to her and assured things would be all right, shortly.

On 11.08.2017 at 8.30 A.M., my daughter with her baby (1½ years) left my home without notice, after an hour or so we started searching her; finding nowhere, I with the help of one Mr. Patal Haldar proceeded to Jhalda in his motor cycle reaching Jhalda, Jamai narrated me that she living her baby with his mother left his home also. The unknown neighbourers of my Jamai told me that my daughter has been her sasural. The sasural people snatch the baby, and scared her away. She proceeded towards main road. I started searching her but at about 2 P.M. could know that a dead body is lying on the railway track behind Block office, Jhalda. I found my daughter head and body are in two parts on the railway track.

I remained busy in getting the legal formalities of getting the body of my daughter from Purulia Yester- evening and remained upset due to constant cries of my wife, daughters and widow mother, hence, some delay caused to make this formal complaint.

The above named persons, all related to husband of my deceased daughter, constantly treated her with unbearable cruelty since 12-13 months in order to get their illegal demand fulfilled and she committed suicide on 11.08.2017 failed to bear that cruelty and as such all of them committed offence of cruelty and a dowry death.

Since I don't know Bangali language and Hindi may be difficult to you, so I wrote it in English language through an interpreter. I am enclosing my Hindi version alongwith this complaint.

I, therefore request you sir, to institute case and get these murderers punished as per law. For this I shall be every pray.
