



The above named Complainant begs to State as follows :-

- 1. That the complainant is the legally married wife of the accused no. 1 and their marriage was solemnised on 12-7-2006 at Arsha P.S. Arsha, Dist Purulia, and after marriage the complainant went to her matrimonial home and lived together as husband and wife with accused no. 1 along with other accused persons in the same mess and house.
- 2. That as the complainant was tortured by the accused persons and further dowry was demanded by them so the complainant was compelled to come to her fathers house at Arsha and filed a case against her husband and relatives i.e. the accused persons subjecting her to cruetly and also filed a case against her husband for maintenance those two cases are still pending in the Court of Purulia. The maintenance case is pending in the Ld. Court of J.M. 4th Purulia and in that case the husband of the complainant appeared and agreed to take back me at my matromanial matromonial home and as per order of the Ld. Magistrate the complainant went to her matrimonial home of village Nowadih with her husband i.e. the accused no. 1 on





on 30.06.2016. The complainant is a worker of I.C.D.C. and worked at Village Bandih, within Illu Jargo Anchal of Jhalda P.S. Under no. 44 of child welfa re project and lived at her matrimonial home.

- 3. That the complainant kept the goods supplied by the authority such as rice, Dal and other things for the Children at her matrimonial home.
- 4. That the accused persons in order to capture the good and to create obstract and also pressure upon the complainant. The complainant raise objection against all the accused person the practice of accused person upon the tale complainant both physically and mentally and on 21.05.2017. Accused Tarapada Mandal, Haradhan Mandal, Tuvu Mandal, Gunadhar Mandal, Santara Mandal, Mihir Mandal and Sikha Mandal assaulted the omplainant and they tried to prace finish her and space stated and Two Mobile Phone from the complainant and they Smatched all the Educational Certificate and Service matter documents and threatened the complainant to kill her by putting fire.
- 4. That the complainant sustained injury and went to Sixkaka B.P.H.C. for treatment and the Doctor of the said B.P.H.C. after examination sent the complainant to Purulia Sadar Hospital for better treatment. The Doctors of the Sadar Hospital Purulia Advise to the complainant



that to save herself it is necessry to miscrry and she compelled to miscarry.

5. That there after the complainant lodge a complain before the Jhalda P.S. on 23.05.2017 though the O.C. /I.C. of the said P.S! Assumed that legal action will be taken against the accused personsbut no action has taken from their ends.

6. That the matter is very serious in nature and according ly Police investigation is required hence the complainant lodged complain before the S.P. Purulia on 24.5.17. But up till now no action has been taken from their ends hence the complainant is filling this complaint before Honours Court today in view of the above detailed facts and circumstance, it is humbly prayed that the presnt application may kindly be eccepted and present complain may kindly be forwared for gegistration and investivation of the case to the Police station Jhalda, U/S 156 (3) Cr. P.C. and justice may kindly be imparted to the complainant.
