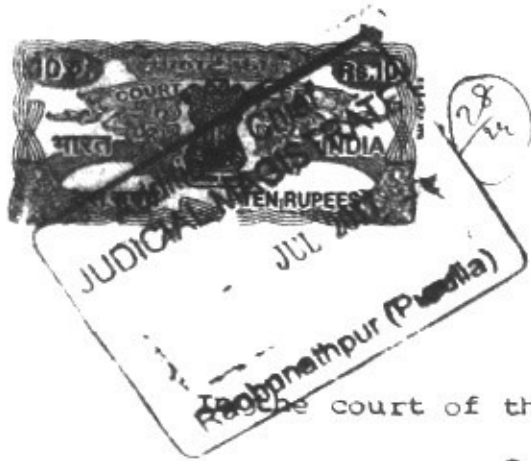

The complainant most respectfully showeth:-

- 1. That the complaint is a resident of vill: Kelahi, PO: Siyada under Kalidaha Gram Panchayet within the jurisdiction Kashi- Kashipur P. S. - pur Block/ Panchayet samity. Purulia (W. B.)
- 2. That the complainant is an illeterate village rustic person belongs to tribal community having no habitable residential house and a very poor person, so his name has been found place in the list of B.P.L. published by the authority concerned.

3. That in pursuance of the above the complainant is a deserving person to have sanctioned a house under the Welfare scheme of the Govt. accordingly authority concerned sanctioned a residential house under I.A.Y scheme in the name of the complainant in the financial year 2013-2014.

4. That it is to be mentioned here that at the relevant point of time and till this day ^{the actual person} has been holding the post of Pradhan of Kalidaha G.P.

5. That the concerning staff of said Kalidaha Panchayet informed the above said fact to the complainant.

6. That having learnt the same the complainant time and again attended the office of pradhan and asked the pradhan on which date his house will be constructed but on each and every occasion the acced. person assured the complainant that there is nothing to ^{be} worried his house to be constructed in time.

7. That the complainant waited for long period thereafter the attended office of the B.D.O. Kashipur panchayet samity who has been figured as PW-3

8. That from the office of the B.D.O. ^{Kashipur} the complainant came to know that his sanctioned house ^{under} and I.A.Y scheme has already being constructed and utilisation has already been submitted by the acced. person, ^{but in fact no any house has been constructed}

9. That the complainant also came to learn that the sanctioned amount of Rs. 75,000/- has been paid through Bank in the account of beneficiary in three installment, but the said amount has not been paid to the complainant through Bank.
