Most respectfully begs to submit as follows:-

1. That the petitioner has purchased a land from one Menaka Kumar wife of Bhubaneswar Kumar pursuant to the agreement. Nimai Kumar, Falguni Kumar, Kalachand Kumar, Fulchand Kumar, Naren Kumar, Biren Kumar, Goutam Kumar all of Village- Bamnia, P.S. Kotshila, Dist. Purulia came to the petitioner's place alongwith Menaka Kumar on 17-10-2016 and proposed to sell 5 decimals of land to the petitioner. The rate of the land also settled at a sum of Rs. 55,000/- and it was also settled between the parties i.e. petitioner and Menaka Kumar that the land would be sold by Regd. Sale Deed. Accordingly on 12-6-2017 was fixed for registration.
