

The humble petition on behalf of the complainant/ petitioner/Aggrived;

Most respectfully begs to state as follows:-

- 1. That petitioner Josada Rajwar is the socially legal married wife of the accused no.1 namely Suraj Bhukura Rajwar of Vill.& P.O.Begunkodar, P.S.Kotshila, Dist.Purulia and their marriage has been solemnised on 24th day of Sraban 3 years back as per Hindu rites and customs and after marriage your petitioner was taken at her husband's house at Vill.Begunkodar.
- 2. That at the time of marriage as per demand of the accused persons father of the petitioner compelled to pay Rs.50,000 alongwith other utensils, ornaments and other household articles as dowry to the accused persons by selling our bastubari and other property.
- 3. That since after 1 year from the date of marriage physical as well as mental torture upon the petitioner was started by all the accused persons. They demand further dowry money of Rs.50,000/- and as and when petitioner protest of such illegal demand all the accu-





- 4. That all the accused persons use to started persistant physical torture upon the petitioner and her daughter regularly and your petitioner stayed at her husband regex house on the hope that good day may will come but on 16.6.2017 at about 11.00 p.m.(night) all the accused persons inflicted physical assault to your petitioner and they snached the iron bangle which was given at the time of marriage as a secret sign of marriage and they also remaned the cinnabar(Sindur) from the forehead and finally they driven out the petitioner and her suching baby from the house.
- 5. That the petitioner alongwith suching baby were no other alternative but to take shelter of the Durga Mandir of Begunkodar village.
- 6. That on the next day i.e. on 17.6.17 petitioner informed the matter to her father and mother and heaving such type of lawrul work of the accused persons father, mother and some other village people petitioner alongwith her father, mother went to the Kotshila a P.S. and informed the entire matter and police assured that legal action will be taken.
- 7. That as and when P.S. did not take any legal action your petitioner informed the matter to the S.P. Purulia on 21.7.17 but all in vain.
