Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Gautam Mahanty, S/O Late Siddheswar Mahanty of Village- Jhanbagda, P.O- Jhanbagda, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 21.08.17 at about 02:25PM I, Sri Bijan Guari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikram Tudu, Sr. SAE(E), Manbazar CCC
- 2) Mrithunjoy Mandal SAE(E), Manbazar CCC
- 3) Sourav Mukherjee, TSH, Manbazar CCC
- 4)

entered the premises of Gautam Mahanty, S/O Lt Siddheswar Mahanty of Village- Jhanbagda, P.O- Jhanbagda, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorinately by direct hooking from WBSEDCL's LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two nos. 60 watt Fan (ceiling) (2x60W)
- 2) One no. 100watt bulb (1x100W)
- 3) Two nos. CFL Bulbs (2x20W)
- 4) One no. LED Bulb (1x9W)

out of which we seized the following -

- 1) One no. 100watt Bulb
- 2) Two nos single core cable apprx 7 mtr (Black & yellow) with hooking
- 3) one no. 15 amp switch board one no. with PVC wire apprx 2.5 mtr, device

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 2:40PM on dated 21.08.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
