I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Ankur Bauri S/O- Late Karali Bauri of Village- Somodarpur (Manbazar) P.O- Bishri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 22.08.17 at about 5:00AM, Sri Bijan Suari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Ankur Bauri, S/O- Late Karali Bauri of Village- Somodarpur (Manbazar) P.O- Bishri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisedly by direct hooking from WBSEDCL's LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
