Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sadhan Bauri S/O Kishnudiram Bauri of Village- Bamodarpur(Manpu) P.O- Bishri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 22.08.17 at about 05:08AM, Sri Bijan Guari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 2) Sourav Mukherjee TSH Manbazar CCC

entered the premises of Sadhan Bauri, S/O Kishnudiram Bauri of Village- Bamodarpur(Manpu) P.O- Bishri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisedly by direct hooking from WBSEDCL's LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) TWO nos. bulb (2X60watt)
- 2) TWO nos. Fan (2X60watt).

out of which we seized the following -

- 1) TWO nos PVC wire (APRX 10mtr) and two nos. Flexible wire (APRX 3mtr)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 05:15AM on dated 22.08.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
