Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sadhan Bauri S/O- Late Kshudiram Bauri of Village- Bamodarpur (Manbazar) P.O- Bishri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 22.08.17 at about 05:08AM, Sri Bijan Suari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sadhan Bauri, S/O- Late Kshudiram Bauri of Village- Bamodarpur (Manbazar) P.O- Bishri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisedly by direct hooking from WBSEDCL's LT line

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 2) Two nos. Fan (2X60Watt)

out of which we seized the following -
