(Tola-Sidhadanga), Raibandh, Neturia, Purulia.

On query, Mr. Arabinda Maji could not submit the reason for his such illegal activity i.e. damaging Government pipeline and on being asked by the worker he threatened them. The above noted person damage the public property and threatened the worker.
