Sir.

In producing herewith one seized dumper bearing no –WB 37B/4095 loaded with seems to be coal dust of 15 M.T. (approx); do hereby lodge a complaint to the effect that today (10/08/17) at about 15.05 hrs, in course of day Mobile Duty, when we reached at Haridih more I received an credible source information to the effect that one dumper bearing no WB 37B/4095 loaded with illegal coal coming from Dishergarh side and will transport the same to Raghunathpur side through Purulia - Barakar road in clandestine manner. I immediately intimated to O/C Neturia PS and acquainted him about the information who directed me to work out the information As per direction of OC, Neturia PS I along with C/1246 Shaktipada Mahato and C/230 Asish Kumar Mahadani immediately started to move towards Dishergarh side through Purulia - Barakar road at 15:15 hours. At about 15.35 hrs. when we reached at nearby Shakambari factory more we found that one dumper was parked there beside the Purulia-Barakar pitch road and we got down from our vehicle and conducted search thoroughly. On search we found that the dumper bearing no – 37B/4095 was loaded with seems to be coal dust of 15 M.T. (approx) but nobody was present there. We also conducted search to the adjacent places but nobody was found & turned up as claimant.

So, there is reason to believe that the driver and registered owner of the said vehicle have obtained the said seems to be coal dust either by theft or by any fraudulent means and tried to dispose of the same seems to be coal dust in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly I **seized** the said dumper bearing no – 37B/4095 loaded with seems to be coal dust of 15 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 16.15 hrs and 16.35 hrs, since no Local People was found & none turned up as witness.

Under the above circumstances a specific case may kindly be started against the 1) driver and 2) Registered owner of dumper bearing no – 37B/4095 under section - 379/411/413/414 IPC.
