Sub: Prayer for starting a specific case u/s 46 A(c) B.E. Act, 1909.

Respected Sir,

In producing herewith one accused person namely Kamal @ Kmala Bouri (35) S/O- Lt. Sibbu Bouri of village Raghudih, PS-Neturia, District- Purulia with seizure of (1) 15 pcs. Sealed bottles of Goldee 80° UP country spirit containing 600 ml each, (2) 10 Pcs. Sealed bottles of Captain country spirit containing 600 ml each which were seized under proper seizure list.

I beg to submit that today (17.08.17) in between 13.05 hrs to 13.35 hrs. a raid was conducted in the house of Kamal @ Kmala Bouri (35) Lt. Sibbu Bouri of village Raghudih, PS-Neturia, District- Purulia situated at Mouza Raghudih under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Kamal @ Kmala Bouri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 15 pcs. Sealed bottles of Goldee 80° UP country spirit containing 600 ml each, (2) 10 Pcs. Sealed bottles of Captain country spirit containing 600 ml each seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accused namely Kamal @ Kmala Bouri (35) S/O- Lt. Sibbu Bouri of village Raghudih, PS-Neturia. District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/207 Dilip Kumar Paul & 2. C/448 Subhankar Mondal both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Kamal @ Kmala Bouri (35) S/O- Lt. Sibbu Bouri of village Raghudih, PS-Neturia, District- Purulia under proper section of law.
