I beg to submit that today (20.08.2017) during my mobile duty as well as raid duty in between 19.45.15 hrs to 20.05 hrs acting on a tip off a raid was conducted in the house of Babulal @ Bablu Mandi S/o Nunku Mandi of Amsola, PS- Para. District – Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 20 (Twenty) pcs sealed bottles of Country Spirit styled as “DIL KHUSH” each Bottle contains 600 ml and in which 01 (one) bottle seized as sample, under proper seizure list in presence of witnesses, duly signed by Babulal @ Bablu Mandi and witnesses and also arrested the above noted accd. person.

The above noted arrested accd. Babulal @ Bablu Mandi S/o Nunku Mandi of Amsola, PS- Para, District – Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of country spirit in his house.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Babulal @ Bablu Mandi) S/o Nunku Mandi of Amsola, PS- Para, District – Purulia and arrange for its investigation.
