Sir,

In producing here with one arrested accused person namely Tarani Mondal (44) s/o Lt Motilal Mondal of vill- Baikata PS Purulia (M) Dist Purulia with seized articles and I loged awritten complaint that today on 25/08/17 during raid duty at 18.15 hrs received a reliable source information that one Tarani Mondal of village Baikata is selling Liquor illegally at Baikata village in his house. After receiving this information myself along with force left for Baikata village to work out the information and 18.45 hrs reached in the house of Tarani Mondal s/o Lt Motilal Mondal of Vill. - Baikata, PS. - Purulia (M) Dist. - Purulia. After seeing the police party he started to flee away. After a hot chase we are able to apprehended him. Then we searched his house. During searching we found 35 bottles DIL SE in his house on demanding the valid papers for possessioning the said DIL SE but he could not produce any valid papers and could not give any satisfactory answer. Accordingly seized the same under proper seizure list in presence of witness duly signed by Accd and witness taken two bottles as sample out of thirty five bottles and leveled properly. Arrested the above noted Accd person after observing all the formalities of arrest. Issued memo of arrest. Inspection memo and informed him and his relatives regarding the ground of arrest. Process of seizure was done inbetween 19.05 hrs and 19.25 hrs.

So I pray before your kond hohour kind take law full action against Tarani Mondal (44) s/o Lt Motilal Mondal of vill- Baikata PS Purulia (M) Dist Purulia from your end.
