Respected Sir,

In producing herewith arrested accused person namely Bishnu Prasad Pandey (55 Yrs.), S/o- Lt. Bhubaneswar Pandey of Vill.- Rudra, P.S.- Purulia(M), Dist.- Purulia along with seized articles as per seizure list.

I beg to submit that on today 26/08/2017 while myself along with force were performing anti crime special mobile duty on Purulia-Ranchi road and when we reached near Rudra village acting on a secret source information myself along with force conducted raid in the shop of Bishnu Prasad Pandey (55 Yrs.), S/o- Lt. Bhubaneswar Pandey of Vill.- Rudra, P.S.- Purulia(M), Dist.- Purulia at Rudra Bus Stand Morh in between 18.05 hrs. to 18.45 hrs. During raid found that the above noted person was selling country spirit at his shop. On demand he failed to produce any valid document in respect of keeping and selling of liquor in his shop at Rudra Bus Stand Morh. On search at the shop of Bishnu Prasad Pandey found (1) 35 (thirty five) sealed bottles of 80° up Country Spirit styled as DIL SE each bottle contains 600 ml 2) 05 (Five) empty bottles of 80° up Country Spirit styled as DIL SE each bottle contains 600 ml. 3) 04 (four) Pcs. plastic glass and I seized the same under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses.

The above noted arrested accused person namely Bishnu Prasad Pandey (55 Yrs.), S/o- Lt. Bhubaneswar Pandey of Vill.- Rudra, P.S.- Purulia(M), Dist.- Purulia committed offence u/s 46 A (c) B.E. Act. 1909 for unauthorized possession and sale of country spirit at his shop at Rudra Bus Stand Morh under Purulia (M) PS.

Under the fact and circumstances I therefore pray before you kindly do the needful against accused person namely Bishnu Prasad Pandey (55 Yrs.), S/o- Lt. Bhubaneswar Pandey of Vill.- Rudra, P.S.- Purulia(M), Dist.- Purulia.
