With due regards I beg to draw your kind attention towards the incident which occurred tomorrow at about 09 pm near Kwik Fast food shop, Amla Para, P.S. - Purulia, Town (PRL)

Tomorrow, I went to the mentioned shop to purchase some food, at that time Kishan came with his friend Dipak Sharma, S/o Bejay Sharma, the resident and neighbourhood of the same mohalla, Kishan drew my ~~coat~~ my collar and

starting to beat me forcefully with his fist and wrist. I tried to oppose but he torn my shirt, he had a knife in his pocket and he was shouting loudly to kill me, spoiled my life. I had Rs. 3000/- (Three thousand only) in my pocket, which fell down or taken away by someone, Kishan snatched my

mobile and threw away, it was cracked. Someone informed my father, who came and told him to stop it, come with him to Town Thana where the Police ~~seth~~ will solve the case. At the meantime I rushed towards thana, but I was badly injured, so I went to the Sadar Hospital to take medicine.

My left ear and left eye were buzzing with pain. I was thinking to take bed-rest due to body-pain.
