Sir,

I lodge this information against my husband namely Bibek Gupta s/o Ghanshyam Gupta, Mother-in-law namely Sushma Gupta w/o Ghanshyam Gupta and Father-in-law Ghanshyam Gupta s/o Late Radheshyam Gupta all are resident of Rambandh, Basanti Math, Burnpur, Burdwan (W.B.) on the following facts.

My marriage was solemnised on 21.04.2015 as per Hindu Rites and Customs and since after the inception of my marriage I have been inflicted to physical and mental torture by my husband Bibek Gupta s/o Ghanshyam Gupta, Mother-in-law namely Susma Gupta w/o Ghanshyam Gupta and Father-in-law Ghanshyam Gupta s/o Late Radheshyam Gupta in want of money from my paternal home. It is pertinent to mention here that before marriage my brother Murali Jainwal took loan of Rs. 4,00,000/- (rupees four lakh), Rs. 60,000/- (rupees sixty thousand) and Rs 3,50,000/- (rupees three lakh fifty thousand) from friends and well wishers to meet the expenses of marriage and to fulfill the demands of my greedy husband and inlaws.

After marriage when I reached my matrimonial home my mother-in-law asked me to handover my jewellery to her. I found this a little stange but quietly took everything off and handed over to my mother-in-law. After few days my husband and my inlaws started demanding more money for setting up business for my husband and when demand could not fulfilled they assualted me on regular basis.

My mother-in-law used to beat me with Jharu and kitchen utensils and whenever I tried to tell to my husband about the incident at night he used to get furious and beat me up with a log. Once my husband and my inlaws locked me in a small room and starved me with an intention to kill me.

When I got pregnant my parents were forced to give money for my treatment but my husband did not incur a penny towards my treatment rather they sent me to my paternal home on some pretext or otherwise.

When I was 5 months pregnant my husband and my inlaws again called me out. On 31.12.2015 my sasu accompanied a Tantrik to home to detect whether the baby I was

carrying in my womb was a male child or female child. After seeing me the Tamrik whispered something in my Sasu's ear and gave me prasad and told me to eat the prasad at night. I ate it at night as it was remembered by my Sasu. Few moment after I ate prasad a severe pain erupted in my stomach. Despite taking me to hospital my husband gave me an unprescribed medicine (pain killer) and after eating while my pain became more severe and i became unconscious. When I regained my consciousness I was informed that I gave birth to a stillborn baby. On the next day in the morning when I informed my parents about my miscarriage he told me to lodge complaint but I forbed him and did not lodge complaint would put and end to our conjugal life.

On 04.12.2016 I was again beaten mercilessly with my husband and my inlaws with fist and blows in want of money. My husband caught hold of my neck with his both hands and tried to strangulate it with an intention to kill me. They also abused me with gutter and filthy language. I somehow managed to escape from their hand and locked myself in a room. On 05.12.2016 I was admitted to hospital by my parents who came after I informed them the incident over telephone. I thereafter shifted to my paternalhome and since then there was/is no attempt on the part of my husband and my inlaws to get me back to their home. Even though my parent and brother contacted them several times and tried to sort things out but they gave out that they will not allow me to enter in their home and then also gave out that my husband will remarry someone and I have no palce in their home.

I have been passing my days here at my paternal home with greate difficulty and temendous hardship.

Thus i request you to take strick action against my husband, my mother-in-law and my father-in-law and put them behind the bars.

I bank upon your co-operation
